Drama of a Gifted Kid LLC, doing business as Drama of the Fittest (“Drama of the Fittest,” “we,” “us,” or “our”), is responsible for the personal information described in this Privacy Policy. Our principal business location is Las Vegas, Nevada, United States. Contact: dramaofthefittest@gmail.com.

This Policy explains how we collect, use, disclose, retain, and protect information through dramaofthefittest.com, our mobile and web applications, coaching communications, and related services (“Services”). It also explains rights that may apply based on your location.

1. Information We Collect

Information You Provide

- Account and identity information, such as name, email, date of birth or age confirmation, country, region, username, and credentials;
- Profile information, such as photograph, biography, goals, preferences, and time zone;
- Fitness and wellness information, such as height, weight, measurements, exercise history, goals, injuries, limitations, activity, workout completion, progress, nutrition logs, hydration, sleep, and check-ins;
- Health-related information you choose to provide, such as medical conditions, pregnancy status, medications, symptoms, dietary restrictions, allergies, and healthcare-provider restrictions;
- Communications, support requests, coaching messages, community posts, survey answers, photos, videos, and testimonials;
- Transaction details, subscription status, purchase history, billing address, and limited payment metadata. Full card information is generally processed by the payment provider rather than stored by us; and
- Consent, waiver, signature, and agreement records.

Information Collected Automatically

- Device, browser, operating-system, app-version, language, and screen information;
- IP address, approximate location derived from IP, time zone, and network information;
- Usage events, pages or screens viewed, interactions, referring URLs, session duration, crash reports, and diagnostics;
- Cookie, local-storage, software-development-kit, and similar identifiers; and
- Security and audit records, including login attempts and agreement-acceptance records.

Information From Other Sources

We may receive information from payment processors, app stores, authentication providers, analytics providers, communication services, referral partners, or integrations you choose to connect. We collect only information reasonably necessary for the disclosed purpose.

2. How We Use Information

We use information to:

- Create and manage accounts;
- Deliver programs, coaching, progress tracking, community features, and customer support;
- Personalize workouts and general educational content;
- Process purchases, subscriptions, refunds, and transaction records;
- Communicate about the Services, safety, account activity, and support;
- Send marketing when permitted and honor opt-out requests;
- Maintain security, prevent fraud, enforce agreements, and investigate misuse;
- Debug, analyze, and improve performance and accessibility;
- Comply with law, respond to lawful requests, and establish or defend legal claims; and
- Create aggregated or de-identified information that is not reasonably capable of identifying you.

We do not use health-related information to make decisions about employment, housing, credit, insurance eligibility, or another legally protected determination.

3. Legal Bases Where Required

Where laws such as the EU or UK GDPR require a legal basis, we rely on:

- **Contract:** to create accounts, provide purchased Services, process transactions, and respond to service requests;
- **Consent:** for optional processing such as certain health information, marketing, nonessential cookies, or public promotional use;
- **Legitimate interests:** to secure, maintain, improve, and understand the Services, provided those interests are not overridden by your rights;
- **Legal obligation:** to keep required records and comply with lawful requests; and
- **Vital interests:** in limited circumstances involving a serious threat to life or safety.

Where health information is treated as sensitive or special-category data, we request explicit consent or rely on another lawful condition where permitted. You may withdraw consent, but withdrawal does not affect prior lawful processing and may prevent us from providing features that require the information.

4. How We Disclose Information

We may disclose information to:

- Service providers that support hosting, databases, authentication, payments, communications, analytics, customer support, security, video delivery, and app distribution;
- Coaches, staff, and contractors who require access to provide Services and are subject to appropriate duties;
- Professional advisers, insurers, auditors, and legal representatives;
- Government authorities or other parties when required by law or reasonably necessary to protect rights, safety, and security;
- A successor in connection with a merger, financing, reorganization, sale, or transfer, subject to applicable safeguards; and
- Other users when you intentionally post in a community or public feature.

We do not authorize service providers to use personal information for their own unrelated purposes. We do not sell personal information for money. If future advertising or analytics practices are legally considered a “sale,” “sharing,” or targeted advertising, we will provide the disclosures and choices required before enabling them.

5. International Transfers

Information may be processed in the United States and other countries where we or our service providers operate. Those countries may have different privacy protections. Where required, we use an approved transfer mechanism, such as contractual safeguards, and take supplementary measures appropriate to the risk.

6. Retention

We retain information only as long as reasonably necessary for the purposes described, including to provide Services, maintain transaction and agreement records, meet legal and tax obligations, resolve disputes, enforce agreements, and protect safety and security.

Typical retention considerations include:

- Active account information: while the account remains active;
- Coaching and progress records: while needed to provide Services and for a reasonable period afterward;
- Signed waivers, consents, and transaction records: for the applicable legal limitation and recordkeeping periods;
- Security logs: for a limited period appropriate to security needs; and
- Deleted information: until removed from active systems and routine backup cycles, unless retention is legally required.

Specific periods may vary by record type and location. We securely delete or de-identify information when no longer required.

7. Security

We use reasonable administrative, technical, and organizational safeguards designed to protect information, including access controls, authentication, encryption where appropriate, logging, backups, vendor review, and least-privilege access. No system is completely secure, and we cannot guarantee absolute security.

If a qualifying breach occurs, we will provide notices required by applicable law.

8. Your Choices and Rights

Depending on where you live, you may have rights to:

- Know or access information about you;
- Correct inaccurate information;
- Delete information;
- Restrict or object to processing;
- Receive a portable copy;
- Withdraw consent;

- Opt out of marketing, targeted advertising, sale, or sharing where applicable;
- Appeal a denied request where applicable; and
- Complain to a privacy or data-protection authority.

Submit requests to dramaofthefittest@gmail.com. We may verify your identity and authority before responding. You may use an authorized agent where local law permits. We will not unlawfully discriminate against you for exercising a privacy right.

You may unsubscribe from marketing using the message link or by contacting us. Service and safety communications may continue while your account is active.

9. Children

The Services are not intended for anyone under 18 or under the age of majority where they reside. We do not knowingly collect personal information from minors. If you believe a minor submitted information, contact us so we can investigate and delete it where appropriate.

10. Community and Public Content

Information posted in community or public areas may be visible to other users and may be copied outside our control. Do not post sensitive medical, identity, financial, or precise-location information publicly.

11. Automated Decisions

We may use rules or algorithms to recommend workouts or display progress insights. Unless we provide a specific notice otherwise, we do not use solely automated processing to make decisions that produce legal or similarly significant effects. Automated recommendations are educational and do not replace human medical judgment.

12. Cookies and Similar Technologies

We use necessary technologies to operate accounts, maintain security, remember settings, and process transactions. With consent where required, we may use analytics or other optional technologies. See the Cookie Policy and consent controls for details.

13. Third-Party Links and Integrations

Third-party websites, app stores, payment services, and integrations operate under their own policies. Review those policies before providing information. We are not responsible for their independent practices.

14. Changes to This Policy
