

Subscription, Cancellation, and Refund Policy

Effective Date: August 10, 2026

Version: 1.0

This Policy applies to purchases from Drama of a Gifted Kid LLC, doing business as Drama of the Fittest. The exact price, currency, billing interval, trial, commitment period, and included Services will be displayed before purchase.

1. One-Time Purchases

A one-time program purchase is charged once at checkout. Access duration, if limited, will be disclosed before purchase. Except where a refund is required by law or expressly promised at checkout, fees for substantially delivered digital content are nonrefundable after access, download, streaming, or delivery begins.

2. Recurring Subscriptions

A recurring subscription renews automatically at the billing interval disclosed before purchase until canceled. By subscribing, you authorize the disclosed recurring charge and applicable taxes using your selected payment method.

Before purchase, we will clearly disclose the amount, frequency, trial or promotional period, renewal terms, minimum commitment if any, cancellation method, and material restrictions.

3. Trials and Promotions

If a trial converts to a paid subscription, the conversion date and price will be disclosed before enrollment. Unless canceled before the disclosed deadline, the payment method will be charged as stated. Promotional pricing may change to the disclosed regular price after the promotion.

4. How to Cancel

You may cancel through the same platform used to subscribe:

- For direct web purchases, use **Account** → **Billing** → **Manage Subscription** → **Cancel Subscription**, or contact dramaofthefittest@gmail.com if the control is unavailable;
- For Apple App Store or Google Play purchases, use the subscription controls in the applicable app-store account; and
- For another authorized platform, use that platform's disclosed cancellation method.

Cancellation stops future renewals. Unless local law or the checkout terms provide otherwise, access continues through the end of the paid billing period and no prorated refund is issued for unused time.

Deleting the app or account does not automatically cancel a subscription. Cancel the subscription separately before requesting account deletion.

5. Refund Requests

To request a refund for a direct purchase, email dramaofthefittest@gmail.com with the account email, purchase date, product, and reason. Requests will be evaluated under this Policy and mandatory local law.

Purchases processed by an app store may require the refund request to be submitted to that store. We do not control the store's decision.

Refunds may be appropriate where required by law, where duplicate or unauthorized billing is verified, where the purchased Service was not delivered, or where we expressly approve an exception. Approved refunds are returned through the original payment method when practicable.

6. Coaching Appointments

If a package includes scheduled one-to-one sessions, rescheduling and no-show rules will be disclosed with the package. Unless different terms are shown before booking, provide at least 24 hours' notice to reschedule. A missed session or late cancellation may be treated as used, except where prohibited by law or where an emergency or reasonable accommodation requires different treatment.

7. Price Changes

We may change future prices. For recurring subscriptions, we will give advance notice required by applicable law before a price increase takes effect. If required, we will obtain affirmative consent. You may cancel before the new price begins.

8. Failed Payments

If payment fails, we may retry the charge as permitted, request an updated payment method, or suspend paid access. We will not impose an undisclosed fee.

9. Mandatory Consumer Rights

Nothing in this Policy limits a mandatory cooling-off period, cancellation right, refund right, legal guarantee, or other consumer protection in your country, state, province, or territory. If local law conflicts with this Policy, local mandatory law controls.

For digital content, you may be asked to expressly request immediate performance and acknowledge any effect that beginning delivery has on a statutory withdrawal right. Such acknowledgment will be requested separately where required.
